### AMCO PARTICIPATES IN THE RESTRUCTURING OF BANCA PROGETTO

Milan, 27 March 2026. AMCO announces that, as part of the restructuring process of Banca Progetto, it has subscribed 50% of a fund<sup>1</sup> which acquired from the Bank a portfolio of non-performing loans guaranteed by MCC and SACE, carrying a guarantee issued by FITD (Interbank Deposit Protection Fund). The portfolio acquired by the fund amounts to approximately €2.1 billion (GBV).

AMCO will act as Master and Special Servicer of the portfolio.
